

CONDITIONS OF HIRE FOR ANY WORK DONE BY Roding Solutions (2011) limited

1. LIABILITY OF RODING SOLUTIONS 2011 LIMITED (such term to include the company and its subsidiaries, its servants, agents and sub-contractors)

(a) This contract shall be "at owner's risk".

(i) Goods are to be hiabed, transported, carted and hauled at 'owner's risk'. This means that Roding Solutions 2011 Limited will pay no compensation for any damages to goods or surrounds whilst hiabing or carting of the goods or damage to; and this contract is in writing expressing it is at "owners risk" and is signed by the parties or their agents relating to the hiabing, transporting, carting and hauling of goods.

(ii) Roding Solutions 2011 Limited shall not be under any liability, howsoever caused or arising, whether caused or arising as a result of the negligence of Roding Solutions 2011 Limited or otherwise for any damage to surrounds or goods whilst loading, unloading, loss during transportation, mis-delivery, delay in delivery or non-delivery.

(iii) The contracting party will indemnify Roding Solutions 2011 Limited against all claims of any kind whatsoever, howsoever caused or arising, brought by any person in connection with any matter or thing done, said or omitted by Roding Solutions 2011 Limited in connection with the goods.

2. Roding Solutions 2011 Limited reserves the right to refuse hiabing, transporting, carting and hauling of goods for any person or for any class of goods.

3. THE goods shall be safely and properly packaged. Failure to safely and properly package shall render the Contracting Party liable for any loss or damage whatsoever caused by such goods. Even if Roding Solutions 2011 Limited is expected to package goods, the Contracting Party shall still be liable for any loss or damage whatsoever caused by such goods.

4. FREIGHT is earned and is due for payment as soon as the goods are loaded by Roding Solutions 2011 Limited without deduction. Payment shall not be withheld or deferred on account of any claim, counter claim or set-off. Should payment in full not be made to Roding Solutions 2011 Limited immediately, unless Business Customers where due within 30 days, then;

(a) the Contracting Party shall pay interest on all amounts outstanding at a rate which is 5% above the rate charged over the relevant period by Roding Solutions 2011 Limited's bankers on primary level overdraft advances to Roding Solutions 2011 Limited, and Roding Solutions 2011 Limited shall be entitled to sue forthwith for the recovery of all outstanding freight and interest thereon and Section 21 of the Act shall not apply; and any costs incurred by Roding Solutions 2011 Limited in connection with recovery action taken in respect of outstanding freight and other charges shall be payable by the Contracting Party on demand.

5. IF the Contraction Party is the consignor, then any special instruction to the effect that freight shall be paid by the consignee shall be deemed to include a stipulation that if the consignee does not pay the freight after delivery then the Contracting Party shall pay the same and all other charges incurred by Roding Solutions 2011 Limited.

6. THE Contracting Party in this document means the person at whose request Roding Solutions 2011 Limited is to provide the carriage of goods.

7. THE goods are accepted subject to a general lien for all charges due now or in the past which may hereafter become due to Roding Solutions 2011 Limited on any account.

7. Insurance of the goods is the responsibility of the Customer.
